Notice for second manual dental WB UG 2018 admission of the allotted candidates out of counseling to be held on 6th September 2018 at Medical College Kolkata

In continuation of the notice of this Department dated 04.09.2018 bearing memo no HFW-23099/4/2018-DIR MES SEC-Dept of H & FW/M/1835 on second manual BDS counseling WB 2018, it is being mentioned here that the dates of admission for the allotted candidates out of counseling to be held on 6th September 2018 at Medical College Kolkata are from 7th September 2018 till 11th September 2018 excluding Sunday from 10 am till 4 pm on all working days as per server time.

The reporting at the respective dental college counter with requisite fee and documents in original is a must for the allotted candidates for admission within scheduled time. The admission has to be secured web based at the respective college counter and the college authority have to admit candidate through the web inter phase of WBUHS.

The option for online surrender without penalty will also remain open on such days and time for BDS institutes as mentioned below.

Any surrender after 4 pm of 11th September 2018 will be with penalty to the respective college unless the seat is filled up in the college level round.

The college counters of Private Dental colleges for second manual round admission will be at RG Kar Medical College Kolkata likewise previous rounds.


