Notice for pre counseling and counseling in West Bengal UG State Quota, Management Quota and NRI Quota seats of Govt. & Private Medical and Dental College 2019

The candidates who have qualified through NEET UG 2019 conducted by National Testing Agency (NTA) and want to participate in the pre counseling and counseling in West Bengal Under Graduate Medical and Dental State Quota, Private College Management Quota and NRI Quota seats 2019, have to follow certain steps as listed below:-

1. State Quota

The pre-counseling phase is introduced to prepare the State Wise Merit list of West Bengal for participation in the State Quota UG Medical and Dental counseling 2019 from candidates who became qualified through NEET UG 2019 and **have selected West Bengal as the state to which the candidate belongs, while filling up the form for NEET UG 2019; and either the candidate or his / her parent/s is domicile for WB.**

Domicile status of the candidate: The candidates who have selected West Bengal as the state to which the candidate belongs, while filling up the form for NEET UG 2019 and subsequently verified for domicile status successfully, will only be eligible for the West Bengal State Quota seats 2019.

If the candidate has not selected West Bengal as permanent residence state or his / her parent/s is not a domicile of WB, but the candidate is an Indian Citizen, then the candidate is eligible to participate in counseling for Private Management Quota seats only.

The types of domicile certificate proforma are being uploaded in the websites <https://wbuhs.ac.in> and www.wbmcc.nic.in are described herewith:-

Proforma a1: Residential/Domicile Certificate for candidates residing in the State of West Bengal continuously for at least last 10 years as on 31st December of 2018.

Proforma a2: Residential/Domicile Certificate for candidates residing in the State of West Bengal continuously for at least last 10 years as on 31st December of 2018 where the candidate has passed 10+2 Examination in the year 2019 or before from West Bengal.

Proforma b: Residential/Domicile Certificate for candidates **NOT** residing in the State of WB continuously for at least last 10 years as on 31.12.2018 but whose parent/s are permanent resident/s of West Bengal having their permanent home address within West Bengal and living continuously for at least last 10 years in West Bengal as on 31st December of 2018.

Local Residence (Domicile) Certificate obtained from the West Bengal e-district portal (<https://edistrict.wb.gov.in/PACE>) will also be accepted as the proof of domicile.

In case **proforma b** or e-district domicile of the parent is furnished, it is required to produce any two of the following original ID proof (Voter ID card, Aadhar Card, Passport) of the concerned parent during the

stage of document verification where the said ID cards show that the residential address is in West Bengal.

Who are authorized to sign the domicile/residential certificate:-

Proforma a1 or b must be signed and certified by any of the following competent authorities of State Govt. or Central Govt. having local jurisdiction of the place of permanent residence of the candidate or the parent as the case may be e.g.:-

1. District Magistrate, Additional District Magistrate, Deputy Magistrate, Deputy Collector, Sub Divisional Officer, Block Development Officer.
2. Superintendent of Police, Additional Superintendent of Police, Deputy Superintendent of Police, Sub Divisional Police Officer.
3. Commissioner, Additional Commissioner, Joint Commissioner, Deputy Commissioner and Assistant Commissioner of Police Commissionerate.
4. Judicial Magistrate of any rank or position in the concerned district or Metropolitan locality or Hon'ble High Court at Calcutta or Hon'ble Supreme Court of India.
5. Corporation area: Commissioner, Additional Commissioner, Joint Commissioner, Deputy Commissioner and Assistant Commissioner.
6. Assistant Secretary or above in the Secretariat of Govt of West Bengal (including GTA) or Central Govt.
7. Deputy Director or above in the Directorate of Govt of West Bengal or Central Govt.

Every official certifying the domicile status of candidate or parent must provide his/her FULL NAME, DESIGNATION, PLACE OF POSTING WITH ADDRESS, LANDLINE or MOBILE Number. He/she should also provide his/her identity card number if available.

Certification from any other authority other than those enumerated above will not be accepted.

Domicile/residential certificate issued by the people's representative like Councilor of Municipal Corporation/Municipality, Member of three tier panchayet system or GTA, Member of Legislative Assembly or Member of Parliament is not accepted.

Proforma a2 must be signed and certified by the Head Master/Principal/Director/ Head of the Institution in the State of West Bengal from which the candidates have passed 10+2 Examination.

2. **Management Quota** in the Private Medical / Dental colleges in West Bengal in 2019 are also going to be filled up by online counseling which is to be conducted by WBUHS. The candidate qualified for NEET UG 2019 for unreserved seats having cut off 50th percentile are eligible for management quota seats. The candidates opting for only management quota seats do not require verification before choice filling. Their documents will be verified at the time of admission.
3. The **NRI Quota** in the Private Medical colleges in West Bengal in 2019 are also going to be filled up by online counseling which is to be conducted by WBUHS. The candidate qualified for NEET UG 2019 for unreserved seats and fulfilled the criteria of eligibility of NRI Quota seats as per the directions/orders of the Hon'ble Supreme Court of India in the case WP (Civil) 689 of 2017 [Consortium of the Deemed Universities in Karnataka (CODEUNIK) and Anr vs. The Union of India and Ors dated 22.08.2017] and Principles set in Anshul Tomar (supra) case in West Bengal and other relevant orders are only be considered in NRI Quota seats. The detailed notice will be issued later on.

4. **Caste status of candidate:-** if the candidate selects SC or ST or OBC A or OBC B during pre counseling, then the candidate will have to answer whether the certificate **WAS ISSUED BY AUTHORITY IN West Bengal**.
If the answer to the question is YES, then the candidate will be considered as reserved category candidate for West Bengal State Quota seats provided their caste certificate is successfully verified as per rule. If the answer to the question is NO, then the candidate is treated as Unreserved for allotment of seats in State Quota Counseling as there is no central institute in WB. The OBC A or OBC B candidates if belong to creamy layer, will not be considered as reserved category candidates.
5. **PWD status:** The candidates who are eligible as per cut off limits of the 21 benchmark disabilities as envisaged under the Regulations of “**The Rights of Persons with Disabilities Act 2016**” will only be considered in PwD (Person with Disability). The detailed information is being uploaded. Such candidates have to verify their PwD status from the Medical Board of **IPGME & R Kolkata** (Address-244, AJC Bose Road, Kolkata 700020) during the stipulated days. Certificate from any other institute will not be considered for eligibility as PwD candidate.
6. In Physics, Chemistry and biology taken together in 10+2 Examination, UR candidates, PwD category amongst UR candidates, and SC/ST/OBC-A/OBC-B candidates must obtained 50%, 45% and 40% marks respectively in order to be eligible for taking part in counseling. They must also pass Physics, Chemistry, Biology & English individually in 10 + 2 examination.
7. **Age:-** Age should be at least 17 years by 31.12.2019. Date of birth must be on or before 01.01.2003 to become eligible.

After the above information is furnished by the candidate, if the candidate is eligible for fee payment then he/she will be directed to the online payment gateway where he/she can pay the **NON REFUNDABLE** pre counseling and counseling fee **ONLINE** only through credit card/debit card or net banking facilities.

Online Counseling fees is Rs 2000/- for Unreserved candidates and Rs 1500/- for SC/ST/OBC A/OBC B/PwD candidates. Bank transaction cost if any is to be borne by the candidate concerned in addition.

Once the fee is paid successfully, the candidate will receive transaction ID, of which a print out shall be taken for future correspondence. Online Acknowledgement receipt will be generated after successful submission of information and fee payment which is also needed to be printed by the concerned candidate for document verification at the allotted venue for State quota and NRI quota candidates.

The date and time of online enrolment for pre counseling and fee payment will be informed shortly. If the candidate fails to participate in pre counseling before Round 1, then there is no chance to participate in Round 1 counseling and admission.

Next step of action to be taken for candidates is to go for physical verification of original documents as will be indicated in the acknowledgement slip with date and time of verification for State quota and NRI quota candidates. Candidates opt for management quota only need not require verification at this stage.

Thus the following documents are required to be produced by the candidates who qualified through NEET UG 2019 in pre counseling by clicking the National Informatics Centre (NIC) website www.wbmcc.nic.in during the time schedule as being published in www.wbmcc.nic.in and <https://wbuhs.ac.in> :-

The documents (in original and self attested photocopy) that are essentially required during the verification are:-

For State Quota

- a. Acknowledgement slip generated online after successful enrollment in pre-counseling.
- b. Domicile certificate (a1, a2, b) or domicile certificate from e-district website as the case may be.
- c. Voter card/Aadhar card/Passport of parent/s in case of domicile certificate of parent is given showing address as West Bengal (any 2 of the three ID cards as mentioned above)
- d. Caste certificate as applicable.
- e. NEET UG 2019 admit card.
- f. NEET UG 2019 Rank card.
- g. PwD certificate issued from IPGMER Kolkata as applicable
- h. Payment of fees proof (generated online).
- i. Age proof (age should be 17 years by 31.12.2019)
- j. Class 10+2 mark sheet for verification of marks
- k. Medical Certificate (from Registered Allopathic Medical Practitioner)

For NRI Quota

Please see separate notice.

For State quota and NRI Quota candidates after proper verification, if the authority finds that candidature is valid, then the online approval and print copy of verified and approved slip will be generated and handed over to the candidate for future reference.

Otherwise, verified and cancelled slip will be printed out and similarly handed over to such candidates. They will not be included in West Bengal merit list and will not be allowed to participate in West Bengal State Quota or NRI Quota Counseling as the case may be. On verification, if the candidate is found as not being a domicile of West Bengal, then the candidate may be allowed to participate in Management Quota if he/she is otherwise eligible for such Quota.

- The date and time of verification will be notified later on.
- Separate eligibility list for State Quota, Private College Management Quota and NRI Quota will be provided.

The eligible candidates can go for online registration, choice filling and choice locking as per schedule being provided in the website www.wbmcc.nic.in

For any kind of suppression of facts/information related to admission in MBBS/BDS courses in West Bengal through counseling 2019 for State Quota, Private college Management Quota or NRI Quota, or fabricated information furnished by candidate at any stage will lead to cancellation of the candidature with immediate effect and would also instigate punitive action.

No personal information will be provided to any candidate. They are requested to visit the websites www.wbuhs.ac.in and www.wbmcc.nic.in frequently for updates and information.
