NOTICE for Round 2 WB UG counseling admission 2019

Allotted candidates for Govt Medical Institute or Govt Dental Institute in Round 2 are directed to report to the respective allotted institutes from 31.07.2019 till 03.08.2019 as per schedule for round 2 published earlier in the counseling website dated 17.07.2019 and subsequent revised schedule dated 25.07.2019.

Allotted candidates for Private Medical institute or Private Dental Institute (State Quota or Private Institute Management Quota or NRI Quota) are directed to report to the respective allotted institute admission desk (**the place of such admission desk will be notified soon**) from 31.07.2019 till 03.08.2019 as per schedule for round 2 published earlier in the counseling website dated 17.07.2019 and subsequent revised schedule dated 25.07.2019.

The candidates already admitted in Round 1 have to take **online release** from the previously admitted institute/ allotted institute admission desk (as the case may be) and take back their original documents deposited in the previous institute and then have to report to the newly allotted institute for admission in Round 2 within stipulated time.

The bond submitted in the previous institute will be null and void and the candidate has to submit bond afresh to the newly allotted institute.

The candidates upgraded from one State Govt. Medical Institute to another State Govt. Medical Institute or, One State Govt. Dental College to another State Govt. Dental College, need not submit fresh fees at the newly allotted institute. They are only required to submit the fee deposit slip of the previously admitted institute to the newly allotted institute. They will not be returned any submitted fee from the previously admitted institute.

For up gradation from Private college to Govt. college or vice versa or from Dental college to Medical college or from Private college to another private college or to the College of ESI Joka or COMJNMH Kalyani, the admission fee will be forfeited and tuition fee with caution deposit will be refunded to the candidate. The candidate has to pay fee afresh in the newly allotted institute. The bond submitted in the previous institute will be null and void and the candidate has to submit bond afresh to the newly allotted institute.

The candidates who are allotted afresh in Round 2, have to directly report to the allotted institute or allotted institute admission desk (as the case may be) with the required fee, original documents and bond (as prescribed in the counseling website).

The candidates have to produce the original EWS (Economically Weaker Section) certificate issued by the competent authority in prescribed format (as the case may be).

Rest of the original documents required and the conditionalities for admission to Round 2 will remain same as per notice dated 08.07.2019 vide memo no OG/WBUHS/2019-20/0801 published in the counseling website www.wbmcc.nic.in

The amount of fee deposited during the admission is divided into the admission fee (non refundable), tuition fee for the first 6 months (first semester) and caution deposit. The tuition fee and caution deposit are refundable if the candidate is upgraded in later round or resigns from the admitted seat before publication of vacant seat matrix of manual round. **Apart from the above**, the tuition fees or caution deposit are non refundable after the publication of the vacant seat matrix of centralized mop up counseling. Moreover, such candidate has to pay the bond penalty to the concerned college.

If any candidate fails to get admitted by depositing the requisite original documents and fees during the stipulated date and time, then the admission will be cancelled and the candidate will be out of the counseling process.

The candidate has to provide willingness for subsequent round during the web based admission at the allotted college. If they are willing for participation in subsequent round, then he/she will be able to participate in subsequent round.

All concerned are hereby informed accordingly.
