**2<sup>nd</sup> Manual UG Dental Counseling West Bengal 2018**

Few Seats in BDS are left vacant after 1<sup>st</sup> manual counseling dated 21.08.2018 and its admission process which was completed by 25.08.2018 due to non reporting and/or surrender of admitted seats in BDS.

**In order to fill up such vacant UG Dental seats, a second manual round of counseling will be held on 6th September 2018 at MEDICAL COLLEGE KOLKATA at 88 College Street, Kolkata 700073 from 11 A.M. onwards.**

The rules for participation in this 2<sup>nd</sup> manual UG Dental counseling round are laid down as below:-

1. Only those eligible candidates who were registered in WB UG counseling for 2018 and yet remaining not allotted in all the rounds of counseling will be eligible for these afore mentioned seats. **The list of eligible candidates for 2<sup>nd</sup> manual UG dental counseling published in departmental website, NIC website and WBUHS website along with the vacancies.**
2. The eligible candidates who are allotted and admitted in earlier round/s are not allowed to participate in this round. Similarly the non reported and surrendered candidates or candidates whose seats were cancelled due to ineligibility due to inadequate documents are also not allowed to participate in this round. **This is in reference to the MCI gazette notification dated 21.05.2018 that candidates who have joined up to mop up round counseling of State are not eligible to participate for further counseling.**
3. An online facility for '**Interest in Participation**' to second manual round of UG Dental counseling for candidates is made available already and will remain available **till 6 pm of 5<sup>th</sup> September 2018** in the website [www.wbuhs.ac.in](http://www.wbuhs.ac.in) likewise previous manual round and the **print out** has to be produced by the intending candidate along with all the original documents as per the FAQ published in [www.wbmcc.nic.in](http://www.wbmcc.nic.in) website and one valid photo ID card in original. This "**interest in publication**" is mandatory for attendance.
4. Counseling will be held as per procedure followed for first SC->then unreserved category seats (including PVT management quota seats). Officers of BCWD Govt of WB will remain present during filling up of category seats.

5. As there is no OBC A or OBC B vacancies so such candidates can participate along with UR candidates and will be called as per combined merit list only.
6. The counseling will be conducted in the UNB hall opposite to the Principal's office (administrative block) while candidates will have to wait/report for web attendance initially to the ACADEMY building adjacent to the UNB hall.
7. Admittance to waiting area in ACADEMY hall for candidates coming with printed copy of interest in participation **will start from 9 am of 6<sup>th</sup> September 2018 and close by 11 am of 6<sup>th</sup> September 2018.** No such candidate reporting after 11 am will be entertained. **Non eligible candidates for 2<sup>nd</sup> manual UG Dental counseling are not allowed in the premises of counseling.**
