Circular to the colleges in West Bengal for UG Medical college level Mop Up 2018

Some seats are found to be still lying vacant in some colleges in West Bengal after completion of the admission process of Manual round WB UG State Quota and Pvt Management Quota counseling Medical and Dental 2018.

The list of the candidates, who are NEET UG 2018 qualified, registered for counseling in WB UG 2018 and not allotted till Manual round, is provided by WBUHS. Such list is published in the Departmental website and NIC website and WBUHS website and candidates whose names appear in such list, are the only eligible persons for college level Mop up Medical WB UG 2018.

In view of the above facts and in pursuance to the order of the Hon'ble Supreme Court of India vide WP Civil 267 of 2017 on 9th May 2017, the pooled vacant seats Medical UG and pooled non allotted candidate list is forwarded to the colleges in West Bengal for consideration of college level admission.

The college authorities are to inform in their website regarding such vacancy and inform such candidates through phone number and email ID regarding such vacancy and willing candidates may attend the office of the Principal/Director of the College on **31.08.2018 at 12 noon. (Cut off time)** along with **all the relevant original documents** (as specified in the **Frequently Asked Questions (FAQ)** in the website www.wbmcc.nic.in and **fees for the concerned college as specified in the News section** of the website www.wbmcc.nic.in already.

The attendees will be called according to merit in NEET UG 2018 for admission provided they produce requisite documents in original and fees for the concerned college. No candidate will be entertained after the cut off time.

All admission in Medical UG closes by 6 pm on 31.08.2018.


The college authority will admit form non-allotted list provided to them after verifying the particulars of intending candidates who registered attendance for admission in a particular college. This is pertinent to mention that the admission will be based purely on merit among the attendees to the respective colleges.

For the SC vacant seats, inter se merit among the SC candidates will be considered provided they have valid caste certificate issued in the State of West Bengal. For the Unreserved seats or MQ seats, the combined merit in NEET UG 2018 will be the sole criteria and eligibility is the UR cut off that is 50 percentile marks in NEET UG 2018.

The admission will be done by computer based application of WBUHS provided to the respective colleges already by WBMCC during the manual round admission.

Any deviation by the concerned candidate found any time before/during or after admission in such seats will lead to cancellation of such admission and rejection of candidature outright.

This circular is issued in the interest of public service and all concerned are informed accordingly.
