

**Notice and Revised Schedule WB UG AYUSH Counseling Stray Round 2023 Regarding**

In pursuance to the letter from National Commission for Indian System of Medicine (NCISM) Ministry of Ayush, New Delhi dated 09-11-2023 reference no. AIAPGET/COE/2023 and in pursuance to the letter from National commission for Homoeopathy (NCH) Ministry of Ayush, New Delhi dated 09-11-2023 reference no. 3-5/2023/NCH/HEB/AYUSH UG Adm.2023-24/7358-7369, the reduction of minimum percentile criteria of NEET UG 2023 for admission to UG Ayush courses in the academic year 2023-24 is by five (5) percentile across all categories is hereby applied from Stray Round WB UG Ayush 2023 Counseling.

**Subject:** Reduction of minimum percentile criteria of NEET UG 2023 and AIAPGET 2023 for admission to ASU&H-Under Graduate and Post Graduate Courses for the A.Y. 2023-24 - reg.

**Re:-** Ministry of Ayush, AACCC-Counseling Cell (AEP-I Section), F.No. L-11011/01/2020 EP-1 dated 09.11.2023.

Sr. Madam,

With reference to the subject cited above and referred letter and with the approval of Competent Authority, I am directed to inform all Counselling Authorities that, it is decided to lower the cut-off percentile by 5 percentile across all categories for admission to UG and PG courses under Ayurveda, Siddha, Unani & Homoeopathy streams of NEET UG 2023 and AIAPGET 2023 for admission to ASU&H-UG and PG Courses for the Academic Year 2023-24 as follows:

Further, in order to implement the percentile reduction and subsequent Counselling processes, it has been decided to extend the cut-off date for admission to ASU&H-UG Courses from 20<sup>th</sup> November, 2023 to 30<sup>th</sup> November, 2023. Counselling Authorities are also advised to allow fresh registrations for remaining rounds of counselling. However, the cut-off date for Post Graduate admissions remains same i.e. 16<sup>th</sup> December, 2023. The data of eligible candidates category wise after reduction of 5 percentile will be shared shortly.

This is one-time measure and applicable only for the current A.Y. 2023-24 and should not be treated as precedent.

With reference to the subject cited above, and referred letter above, the approval of competent authority regarding reduction in the **minimum qualifying percentile** criteria of NEET-UG 2023 and AIAPGET 2023 by five percentile and **cut-off date** across all categories (as per table below) for admission in Homoeopathy - Undergraduate & Postgraduate Courses for the academic year 2023-24 is hereby conveyed for wide public circulation and necessary action.

OBC	35 <sup>th</sup>

SC-PwD	35 <sup>th</sup>
ST-PwD	35 <sup>th</sup>

Further, the minimum cut-off percentile for EWS-PwD category shall remain unchanged i.e. 40<sup>th</sup> percentile as was earlier and the cut-off date for admission in undergraduate course shall be 30<sup>th</sup> November, 2023 and that for the postgraduate course shall be 16<sup>th</sup> December, 2023. This is a one time measure and applicable only for the current A.Y. 2023-24.

The student database for the same shall be shared shortly/made available to State Govt./ Counseling authorities on receipt of request.
