Notice for PG Medical / Dental Seat Surrender of Admitted candidates till Round 2 and PG Medical Choice fill up and allotment in Round 3 WB State Counseling 2023 regarding

In view of representations received and after careful consideration as it is found that the possible publication of allotment result of round 3 All India Quota PG Medical / Dental seats is scheduled to be on 16.09.2023, hence an extended period of seat surrender /withdrawal /resignation is allowed for the candidates who are remaining admitted after the end of round 2 admission schedule in WB State Counseling PG Medical / Dental 2023 so that after such surrender they may move for admission to allotted seat in All India Quota round 3.

The date and time of such seat surrender would be 18.09.2023 and 19.09.2023 from 11 am till 4 pm both days included as per server time. Such seat vacated by surrender shall be added in the seat matrix in WB PG Round 3 counseling 2023. The candidates who surrender from WB PG Medical/Dental counseling must remember that they are out of WB PG Medical/Dental Counseling 2023 process due to such seat surrender. Such seat surrender shall be with forfeiture of deposited fee. The candidate who wants to surrender the seat have to appear in person before the respective admitted college and have to apply in own handwriting the cause of such seat surrender. The college authority then would provide online NIC server generated seat surrender receipt to such candidate along with return of original documents.

The candidates who are allotted in All India Quota PG Medical / Dental Round 3 counseling 2023 and decide to get admitted /join in 3rd round of All India Quota counseling, shall not be permitted to resign from such seat and they will not be allowed to participate in any further rounds of counseling after joining the 3rd round of All India Quota counseling. This is as per the information bulletin and counseling scheme published by Medical Counseling Committee, DGHS, Govt. of India in their counseling website www.mcc.nic.in in page no. 6. Hence such candidates who decide to get admission in AIQ round 3 along with candidates who retain their seats in AIQ round 3 must not fill up choices in WB PG Medical /Dental round 3 counseling 2023 in order to prevent deliberate seat blocking.

Such candidates as stated above , even if fill up choice and get allotted in WB PG Medical /Dental round 3 counseling 2023 , shall not be allowed to get admission in West Bengal Counseling round 3 and such seats shall be made vacant and would appear in West Bengal Stray round counseling seat matrix WB PG Medical /Dental 2023. Such candidate list (who even after getting admitted in AIQ round 3/ remaining admitted in AIQ round 3 and also appears in the allotted list of WB State Counseling round 3) shall be shared with medical counseling committee , DGHS, Govt. of India and National Medical Commission with request to take strict action against such candidate for deliberate seat blocking.

The candidates who remaining admitted after AIQ round 3 counseling shall be excluded from eligible list for WB State Counseling online stray round 2023 for obvious reasons that such candidate cannot participate in any other counseling and cannot release their seats as per the information bulletin and counseling scheme published by Medical Counseling Committee, DGHS, Govt. of India in their counseling website www.mcc.nic.in in page no. 6.

This is in the interest of public service and all concerned are hereby informed accordingly.
