Sub :- Seeking permission for De-Reservation of reserved seats for admission in Under/Post Graduate courses for the academic year 2024-25

Sir,

I am directed to refer to your Ref No: CUMCH/10623 dated 19.11.2024, received from Principal of The Calcutta Unani Medical College & Hospital and to state that the following order is issued provided the college authority has complied with all rules and regulations for the academic session 2024-2025 to all UG 2024 courses on the above mentioned subject and to say that out of seats allotted as per Sec 3(1) of the WBSHE (Reservation in Admission) Act, 2013 for **Sch. Caste, Sch. Tribe**. the number of seats as shown below, has been left unfilled for non-availability of qualified candidates from the reserved categories.

Now, as per Rule 8 of the W.B.S.H.E.I. (Reservation in Admission) Rules, 2013 and in terms of the provisions contained in this Department's Order No.1032-BCW, dt.7.5.1999, I am to convey the approval for filling up by the general candidates of the unfilled seats reserved for **Sch. Caste, Sch. Tribe** for admission to the courses as stated below, subject to the condition that admission shall be made from amongst the general candidates in the original panel of admission to the aforesaid session who were left out for want of seats and that no new candidate outside the original panel shall be considered for any of the said seats. **Accordingly a de-reservation order was issued by memo no 1700-BCW/MRA-06/2024 dated 25.11.2024. But as per the letter published by the National Commission for Homeopathy, New Delhi dated 22/11/2024 bearing file no 3-5/2024/NCH/HEB/Ayush-UG Adm.2024-25/6428-6435 and letter published by the Government of India dated 12.11.2024 bearing ref no NCISM/Examination/State DME/2024 the panel was extended for new candidates. Still no reserved candidates were available after proper admission procedure, so accordingly in issuance of this de-reservation order the previous a de-reservation order issued by memo no 1700-BCW/MRA-06/2024 dated 25.11.2024 stands cancelled.**
